The Veteran Services Office is here to ensure all student veterans and their family members receive the support they need and deserve as they pursue their education goals. It is their focal point for veteranrelated issues, regardless of whether the student is attending in Greeneville, Morristown, or Knoxville or whether they are traditional, adult learners, or online. VETERAN'S EMPLOYMENT AND VOLUNTEERING

Pre-Graduation Employment

Most student veterans may already have employment while they are pursuing their degree. However, some may be looking for part-time or full-time employment while attending school. Each person's experience and gualifications are different so it would be difficult to list all the various employment resources. In addition to the sources which follow, you may want to consider a work study through the Veterans Administration. Although the pay is only at the higher of state or federal minimum wage, it does allow for work schedule flexibility and may get your foot in the door if you want to look at the VA as a permanent place of employment post-graduation. Internships and Job Shadowing

Opportunities for internships for college credit, pay, and/or experience are possible. Post-Graduation Employment

Post-graduation employment starts well before you receive your diploma. Networking, preparing your resume, honing communication and interviewing skills are all areas you need to work on in advance. The Career Services Office (423) 636-7447 is a must-stop as they can provide you with resources to improve skills that may land you that new career. It is never too early to start!



As your graduation date gets closer, you want to start getting your resume prepared, polished, and out there. Do not wait until you graduate to start! As a veteran, you may have veteran preferences for jobs (especially federal jobs) and your preference may increase if you have a service-connected disability rating. The federal government is a great source of job openings for veterans because of their hiring preferences for veterans. Most federal jobs are posted on www.usajobs.gov and advertises jobs both in the United States as well as overseas. The internet is filled with job search sites and this resource book will point you to other sources as well...use them all.

Skills Through Volunteering and Involvement

Some employers receive hundreds of resumes for one job opening. They must then find the one person that sticks out. Volunteering and being involved in organizations are excellent ways to put you above the rest. It shows motivation, leadership, a desire to help your community and involvement that employers like to see. You also pick up life skills like communication and teamwork. It is tough to find the time to volunteer and be involved while in college but some of your peers are doing it; don't let them be the one future employers select for your dream job. There are always opportunities to get involved around campus and the community and you don't have to overload yourself; just be there when you have the time.

Green Zone

Tusculum's Green Zone Program started in April 2017 to address student veteran issues and needs. Volunteers from the staff and faculty receive training on various issues ranging from potential difficulty in transitioning to civilian life, posttraumatic stress and adjusting to the classroom.

Student veterans can rest assured that although these staff and faculty members are not experts in veteran issues, they have a desire to help our veterans succeed in the classroom. They have resource points of contact for campus, local, state and federal veterans programs and organizations and receive notifications on changes or updates to veteran programs and issues.

These volunteers are identified by a Green Zone display on their office doors (see below). If any student feels like they are overwhelmed, stressed, or just need some help locating campus, local, state, or federal resources, they should look for this display. Veteran Designation on Driver License or Photo ID

Tennessee allows a veteran designation on your driver license or on a state-issued Photo ID. This could satisfy proof of veteran status for various programs and discounts. Contact your local Department of Motor Vehicles (DMV) with the original or certified copy of your DD Form 214. Recommend taking a copy as well for the DMV's files.

Discounts

Many local and national businesses offer discounts for goods and services. Always ask about a military discount. If you do not have a military or retired military ID card, most businesses will request to see your DD Form 214 and photo ID. Always carry a copy of your DD Form 214!

Requesting a Copy of Your Military Transcripts

While in the military, you most likely attended courses in job-related skills training and leadership (among others). These courses may have awarded you college credit. To obtain transcripts go to the website shown below. The JST website is very picky to which internet browser you use so you may need to try a different browser if you cannot access it.

Requesting a Copy of Your DD Form 214

Upon separation/retirement from the military, a copy of your DD Form 214 is maintained at the National Archives in St. Louis. To request a certified copy, you can either do it online through eVetRecs or by Standard Form 180 (SF 180). Instructions for both (and access) can be found at https://www.archives.gov/veterans/military-service-records

Requesting Replacement Medals

The military services will issue a one-time replacement of medals to military veterans (next-of-kin may also be eligible to request medals of a deceased veteran). These requests can be in writing or online. To learn more and request medals, visit https://www.archives.gov/veterans/replace-medals.html

Requesting Military Records

Veterans may request a copy of all of their military records that are archived in St. Louis upon discharge from the military. Requests can, in some cases, take weeks to process but can be requested by visiting https://www.archives.gov/veterans/military-service-records

Correction of Military Records

In some cases there is a need to correct something in a veteran's military record. This can range from a typo on the DD Form 214 to a request to change the character of discharge. Each military service is responsible to review and approve/deny requests (the National Archives is only a storage/ maintenance function). There are two forms used to request a change to military records. DD Form 293, Application for the Review of Discharge or Dismissal from the Armed Forces of the United States is used if you have been discharged for less than 15 years and want to change the type of discharge (i.e., from General to Honorable). All other requests would be submitted on DD Form 149, Application for Correction of Military Records.

You must fully justify your request as, in almost all cases, you only get one shot. You should visit the below websites for guidance prior to requesting the change and, once completed, send the requests with any supporting evidence to the branch you served in (addresses below).

VA Home Loans

The VA has a home loan that veterans may be eligible for. This program can help veterans get a home loan with little or nothing down and lower interest rates. The VA does not provide the mortgage but guarantees a large portion of it. Most home lenders are aware of the VA Home Loan program and can help you with the application process. Veterans Burial Benefits

Veterans discharged under conditions other than dishonorable and their immediate family may be eligible for VA burial and memorial benefits. These benefits could range from free burial in a national cemetery, burial allowances, military funeral and/or a burial marker. Death of a dependent family member does not have to occur after the death of the veteran to be eligible. Ensure those responsible for making your final arrangements have access to your DD Form 214 and know your wishes. Most funeral homes will work with next of kin to apply for these benefits or the state veteran service officers listed previously in this guide can also assist.

EDUCATION BENEFITS AND **SCHOLARSHIPS**

The Veterans Administration (VA) has several education programs for veterans, family members, and surviving family members. These include the Post 9/11 GI Bill, Montgomery GI Bill - Active Duty, Montgomery GI Bill - Selected Reserve, Dependents' Educational Assistance, the Fry Scholarship, and Vocational Rehabilitation & Employment (VR&E). Military branches and the State of Tennessee also have education programs and scholarships military personnel may be eligible for. All education programs can be complex, so anyone needing general information on these programs should contact

Whether or not VA education benefits are being used, scholarship and grant opportunities are available. If you receive VA education benefits you can receive scholarships only if they are for other than tuition and textbooks. Several scholarships can be found at http://www3.tusculum.edu/giving/scholarshipsendowments/. Many organizations also provide scholarships to both veterans and family members of veterans. The next few pages also list some but these can change, some can be added, and others may be deleted, make sure you check each site for current information. Also check the national veteran organizations at the end of this guide. Tusculum also provides a full-tuition USS Greeneville Scholarship for veterans or family members who are/were assigned to the USS Greeneville during their military service.

SCHOLARSHIPS MILITARY & VETERANS

Tennessee Helping Heroes Grant

Must be honorably discharged (all branches active, guard, or reserve), be a Tennessee resident for one year and awarded the Iraq Campaign Medal, Afghanistan Campaign Medal, or Global War on Terrorism Expeditionary Medal on or after Sept. 11, 2001. The award amount is \$1,000 per semester for a student who successfully completes twelve (12) or more semester hours with no failing final grade. The student shall receive \$500 per semester for successfully completing six (6) to eleven (11) semester hours with no failing final grade. The student shall not receive an award if enrolled in fewer than six (6) semester hours.

The application deadlines are: September 1 for fall enrollment, February 1 for spring, or May 1 for summer enrollment.

AMVETS Scholarships

Three specific scholarships for Veterans, Active Duty, Guard/Reserves:

- \$4,000 The AMVETS Scholarship
- \$12,000 Dr. Aurelio M. Caccomo Family Foundation Memorial Scholarship
- \$1,000 Henry G. Huestis Memorial Scholarship

Military Order of the Purple Heart (MOPH)

A competitive scholarship program that awards approximately eighty (80) scholarships to Purple Heart recipients. Applications are usually due in January. http://purpleheart.org/Scholarships/



Army Women's Foundation Legacy Scholarship

Provides grants to women soldiers, past and present. Applicant must be a woman who has served or is serving honorably in the U.S. Army, U.S. Army Reserve or Army National Guard. The Legacy Scholarship Program offers financial support in four areas: Certificate programs, Community College coursework, Undergraduate Degrees, and Graduate Degrees. Scholarships are awarded only for coursework from accredited institutions. Scholarships are based on merit, academic potential, community service, letters of recommendation, and need.

Applications are usually due mid-January.

• Community College and Certificate Program Legacy Scholarships awards up to \$1,000.

AFCEA War Veterans Scholarship

Merit-based scholarships of \$2,500 for active duty military honorably discharged military veterans (including Reservists and National Guard personnel) of the Enduring Freedom-Afghanistan or Iraqi Freedom Operations (years 2004-present) who are currently enrolled and attending classes in an undergraduate program part time or full time in an eligible STEM major degree program at an accredited four year college or university. STEM majors are Biometry/Biometrics, Computer Engineering, Computer Forensics Science, Computer Programming, Computer Science, Computer Systems, Cybersecurity, Electrical Engineering, Electronics Engineering, Geospatial Science, Information Science, Information Technology, Information Resource Management, Intelligence, Mathematics, Network Engineering, Network Security, Operations, Research, Physics, Robotics Engineering, Robotics Technology, Statistics, Strategic Intelligence, and Telecommunications Engineering. *Applications are usually accepted between August and November.* http://www.afcea.org/site/?q=foundation/scholarships/war-veterans

Paralyzed Veterans of America Scholarship

Scholarships for Paralyzed Veterans' members through the Paralyzed Veterans' Educational Scholarship Program. The program will provide a \$1,000 scholarship to each qualified individual, up to approximately \$10,000 in total scholarship funding. **Applications are usually accepted in June.** http://www.pva.org/find-support/scholarship-program

Army Nurse Corps Association Scholarship

For those who are serving or have previously served in any branch, and at any rank, of a component of the US Army (Active Army, Army National Guard and Army Reserve) and who are not currently receiving funding by a component of the US Army, (e.g., scholarship ROTC students and students receiving full GI Bill benefits) and are currently enrolled in an accredited baccalaureate or advanced degree nursing or nurse anesthesia program. **Check their website in the fall for application deadlines.** http://e-anca.org/Scholarships

VFW's "Sport Clips Help A Hero Scholarship"

Provides service members and veterans with scholarships of up to \$5,000. Must be retired, honorably discharged, active duty, or a member of the National Guard or Reserve and separated with or currently hold a military rank of E-5 or below and demonstrate a need for financial assistance.

Applications are usually accepted January 1 through April 30 for fall semester and August 1 through November 15 for spring semester.

First Command Educational Foundation Donaldson D. Frizzell Scholarship

Open to active, guard, reserve, retired, or non-retired veterans and their dependent family members. \$30,000 in scholarships distributed in 2017 in two student categories (Traditional and Non-traditional). The final number of awards and amount of awards is determined by an independent Scholarship Review Committee. Selections are based on an assessment of merit, strength of applicants' recommendations, and quality of the applicants' essays. Scholarships can be awarded to those seeking accredited trade school certifications and associate, undergraduate, and graduate degrees.

Women Marines Association Scholarships

The number of scholarships is determined by the annual earnings from the scholarship investments. Applicant must have or be serving in the US Marines or Marine Reserves.

- WMA Memorial Scholarships of \$1,500 or \$3,000 based on number of applicants
- The Lily H. Gridley Memorial Scholarship in the amount of \$1,500
- The LaRue A. Ditmore Music Scholarship in the amount of \$1,500 or \$3,000 based on the number of qualified applicants
- \cdot One Ethyl and Armin Wiebke Memorial Scholarship in the amount of \$1,500
- \cdot One Major Megan McClung Memorial Scholarship in the amount of \$1,500
- The Agnes Sopcak Memorial Scholarship in the amount of \$1,500 or \$3,000 based on the number of qualified applicants
- One Virginia Guveyan Memorial Scholarship in the amount of \$1,500

Additional scholarships in various amounts may also be given.

Applications are usually accepted from November 1 through February 28.

Army Aviation Association of America (AAAA) Scholarship

The AAAA Scholarship Foundation, Inc., established an ongoing program of providing scholarship grants to those sons and daughters of its members and deceased members who sought collegeentry financial aid. The program has since been expanded to also provide both scholarship grants and loans to members who seek further education, as well as the spouses, siblings, and children of members or deceased members. The Foundation has awarded individual scholarship grants each year, ranging from \$1,000 to \$10,000 given out as one, two or four year scholarships. Interest-free loans of up to \$4,000 (\$1,000 a year) are also available. Applicant must be a AAAA member, the spouse of an AAAA member or deceased member, the unmarried son or daughter of an AAAA member or deceased member, or the unmarried grandchild of an AAAA member or deceased member.

Applications are usually accepted between January 1 and April 1.

Tillman Military Scholars Program
